 - a. On off line options needed for participation. Topics: Environment, weather, water and transparency.
 - b. Detroit Land-bank and Youth. Some people wanted to dissolve the Land-bank.
 - c. Blight and safety. Topics: Land-bank & home occupancy. People at table suggested having non-profits take over land-bank properties.
 - d. Violence and Schools.
 - e. Money. Topics: Student council, honor society, recreation center, trash-pickup, and housing.

f. Issues like Land, fast driving on the streets, and others come up repeatedly. The consensus was a need to educate people about who the correct public officials are to handle particular problems. Chairperson Harris suggests a flow chart to share with the community. Also considered as a topic for the August meeting.
